The Board approved the collateral pledged by Polk County banks and held in custody by the County Treasurer.

The following fees for the month of September were earned by the various offices and submitted to the County Treasurer. County Treasurer receipts show fees earned were credited to the appropriate county funds.

A motion was made by Westring to approve a resolution which adopts the most recent and FEMA approved version of the Central Platte NRD Multi-Jurisdictional Hazard Mitigation Plan Update as presented by Emergency Manager Logan Watts. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye; Boss, aye.

A motion was made by Westring to approve the Training Agreement for a Polk County Deputy who is currently attending the Law Enforcement Training Center. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye; Boss, aye. Should the deputy leave employment with Polk County during the three year period following certification, they would be required to reimburse the County for the costs of training.

Adding a building next to the County Jail for housing county equipment and vehicles was discussed. The original plans will need to be altered to meet the setback requirements from the alley and the street.

Erika Schmidtberger met with the Board to ask for approval for a special designated permit to have alcohol at a function to be held on the Polk County Fairgrounds. A motion was made by Boruch to allow Polk County Recreational Assn. to sell and serve alcohol on November 5th, 2022 in the Ag Pavilion on the Polk County Fairgrounds. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye.

LeRoy Gerrard with the Stromsburg Legion Post met with the Board to discuss the date for County Government Day. The date has been scheduled for November 21st, the Monday of the week of Thanksgiving, which is the date that has been approved by the schools for several years. This year, there is the potential for a conflict with the NSAA's state championship football games for Classes D1 and D2. It was suggested that the four schools based in the county be contacted to see if an alternate date can be scheduled, potentially at the end of the week prior to Thanksgiving. The alternate date would only be used if one of the schools in the county has a football team participating in the championship game on November 21st. Gerrard will contact the schools to see if an alternate date can be arranged.

Jana Hughes met with the Board to introduce herself as a candidate for the District 24 Legislature seat.

At 10:35 a.m., a motion was made by Boruch to go into executive session to discuss an application for general assistance. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. Also present were the applicant and the County Clerk. At 10:40 a.m., a motion was made by Boss to come out of executive session. The motion was seconded by Boruch and all members voted in the affirmative. Chairman Westring stated for the record that no formal action was taken and that only general assistance matters were discussed. A motion was made by Boss to approve the applicant's request for assistance with back rent. The motion was seconded by Westring and the roll call vote was Boss, aye; Westring, aye; Boruch, aye.

At 10:50 a.m., a motion was made by Boruch to go into executive session to discuss an application for burial assistance. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. Also present were the applicant, acting on behalf of the deceased, and the County Clerk. At 10:55 a.m., a motion was made by Boruch to come out of executive session. The motion was seconded by Boss and all members voted in the affirmative. Chairman Westring stated for the record that no formal action was taken and that only burial assistance matters were discussed. A motion was made by Boruch to approve the applicant's request for burial assistance. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye.

Highway Supt. Theis updated the Board on the work being done in the Road Dept. The paving on the blacktop road south of the Platte River bridge has been completed with the striping to be done this week. The County is in charge of the shouldering work and there should be enough material in the ditches adjoining the road for the shoulders without hauling in additional dirt. Boruch Masonry is working on some of the problem spots on the blacktop north of Osceola. Two 72' arch culverts will be ordered for the Center Road bridge project and work will begin after harvest, weather permitting. Supt. Theis has visited with one of the owners of the property adjacent to the bridge on the Butler County line about a possible solution to bypass the bridge instead of replace it.

There being no further business, the Board adjourned at 11:50 a.m. to meet again on October 25th and November 1st, 2022. An agenda of the meetings will be available at the office of the County Clerk.
