County Attorney Chris Johnson met with the Board to discuss the use of a software program for the management of digital evidence such as pictures and videos from body cameras. The program, available through Guardify, allows for the storage and electronic transfer of digital documents and videos using a HIPAA compliant process. The initial annual cost is approximately \$5,100 and is renewable on a yearly basis. A motion was made by Boruch to approve the purchase of the Guardify digital evidence management system for the County Attorney's Office. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye.

A motion was made by Westring authorizing the Chairman to sign the Annual Certification of Program Compliance to the Nebraska Board of Public Roads Classifications and Standards. The motion was seconded by Boss and the roll call vote was Westring, aye; Boss, aye; Boruch, aye.

A motion was made by Boruch to adopt a resolution authorizing Chairman Westring to sign the supplemental agreement with E & A Consulting Group, Inc. for the preliminary engineering services for the NDOT Bridge Project Number BRO-7072(17). The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. The supplemental agreement was necessary to add additional services and compensation to the original agreement.

A motion was made by Boruch to adopt a resolution authorizing Chairman Westring to sign the supplemental agreement with HDR Engineering, Inc. for environmental services for the NDOT Bridge Project Number BRO-7072(17). The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. The supplemental agreement was necessary to add additional services and compensation to the original agreement.

Highway Supt. Theis also updated the Board on the work being done in the Road Dept. The contractor is currently doing the patching for the overlay project north of Shelby and has discovered that more patching is needed that had been estimated. After some inquiries, it

appears that there could be in increase in rail traffic through the county to transport the soybean oil produced at the AGP plant near David City. If the county supplies the stop signs, the railroad would install the stop signs at the rural crossings. A resolution to install traffic control devices at the crossings would be required. Supt. Theis reported that the surplus motor grader sold for over \$50,000 at the online auction. He has also reached out to Congressman Flood's office to see if the current government shut down will create issues with the appropriation for the Lone Star West project.
