The County Jail Report for the month of October was reviewed by the Board and approved.

A motion was made by Boruch authorizing the Chairman to sign the engagement letter with Contryman Associates for the county's 2023-2024 audit. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye.

A motion was made by Boss to sign the agreement with the Administrative Office of the Courts and Probation for calendar year 2025 which combines the offices of the county and district courts and authorizes the Clerk Magistrate to perform the duties of the Clerk of the District Court. In return the County shall reimburse the Office of the Court for half of the salary of the Clerk Magistrate. The motion was seconded by Westring and the roll call vote was Boss, aye; Westring, aye; Boruch, aye.

A motion was made by Boruch to approve the interlocal agreement with Platte County and the City of Columbus for joint emergency communications and dispatch services. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. The agreement, which is an extension of the original agreement, will be for five years at an initial annual cost of \$169,560 with annual increases of the greater of 2% or the CPI.

A motion was made by Westring to approve a three year maintenance agreement with Rasmussen Mechanical Services for performing annual preseason tune up of the courthouse boilers. The motion was seconded by Boss and the roll call vote was Westring, aye; Boss, aye; Boruch, aye.

Other counties in the Region V Systems and Apace area requested language changes to the amended agreements previously approved by the County Board on September 17th. A draft of the proposed languages changes was reviewed by the Board and a motion was made by Boss to approve the changes. The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye.

A motion was made by Boruch to approve the purchase of a new Chevrolet Tahoe to be used as a patrol vehicle for the Polk County Sheriff's Department. The motion was seconded by Westring and the roll call vote was Boruch, aye; Westring, aye; Boss, aye.

Highway Supt. Theis updated the Board on the work being done in the Road Dept. A thumb for the excavator has been purchased and will be installed onsite. More hardware has been ordered for installing the stop and stop ahead signs and the power post driver has made the task of installing the posts much easier. Bids have been received from Frontier Coop and quotes are being sought from Sapp Bros for a DEF storage system.

There being no further business, the Board adjourned at 11:40 a.m. to meet again on November 19th and 26th, 2024. An agenda of the meetings will be available at the office of the County Clerk.
