The County Jail Report for the month of October was reviewed by the Board and approved.

The inventory of the Polk County Extension was reviewed by the Board and approved.

A motion was made by Westring to transfer \$23,000 from the Inheritance Tax Fund to the Highway Bond Fund as budgeted. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye; Boss, aye.

A motion was made by Boss to sign the agreement with the Administrative Office of the Court for calendar year 2024 which combines the offices of the county and district courts and authorizes the Clerk Magistrate to perform the duties of the Clerk of the District Court. In return the County shall reimburse the Office of the Court for half of the salary of the Clerk Magistrate. The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye.

A motion was made by Boruch to adopt a resolution stating Polk County's intentions to recommit to the interlocal agreements with various other Nebraska counties and other public agencies that form the Nebraska Intergovernmental Risk Management Association (NIRMA) and the Nebraska Intergovernmental Risk Management Association II (NIRMA II). The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye.

A Memorandum of Understanding for the 30/64 connector project was presented to the Board for approval. The agreement, which has been adopted by the Platte County Board of Supervisors, covers the pursuit of grant funds to pay for a comprehensive engineering planning study and also includes the City of Columbus, Butler County, and Colfax County in the project. A motion was made by Boss authorizing the Chairman to sign the interlocal agreement as presented. The motion was seconded by Westring and the roll call vote was Boss, aye; Westring, aye; Boruch, aye.

Two bids were received for the fire alarm system upgrade for the courthouse. After reviewing the bids, a motion was made by Boruch to accept the low bid of Protex Central for \$109,669.35 with the project to be paid for with ARPA funds. The upgrade will include a new fire alarm panel and wireless detectors.

Assessor Krance presented a revised contract with Central Plains Valuation, LLC for the reappraisal of the residential parcels in the four towns. The Nebraska Dept. of Revenue Property Tax division requested a wording change in the original contract that was approved by the Board at the last meeting. A motion was made by Boss authorizing the Chairman to sign the revised contract for property reappraisal with Central Plains Valuation, LLC as presented. The motion was seconded by Westring and the roll call vote was Boss, aye; Westring, aye; Boruch, aye.

At 11:00 a.m., bids were opened for a new motor grader. Bids from three vendors and two "no bids" were received. Representatives from A1 Iron Corp., Nebraska Machinery Company, and Murphy Tractor reviewed their bids with the Board and Supt. Theis. Action on the bids will be taken at the November 21st meeting of the Board.

No bids were received for a telehandler.

Highway Supt. Theis also updated the Board on the work being done in the Road Dept. The semi tractor is still being worked on but the pickup getting a new transmission is back in service. Foreman Ericson would like to add clay to a portion of Q Road in the valley and culvert projects will be worked on both this week and next, weather permitting. The cracks will be sealed on the concrete road north of Polk as well. Repair estimates have been received on two of the motor graders but Supt. Theis will review the estimates to see if there is some work that the crew can do to lower the cost. Bridge inspections will also begin soon.
