The County Jail Report for the month of November was reviewed by the Board and approved.

A motion was made by Boss to designate the Polk County News as the official Polk County newspaper for 2025. The motion was seconded by Westring and the roll call vote was Boss, aye; Westring, aye; Boruch, aye.

Applications for appointment as county depository banks received from Pinnacle Bank, Cornerstone Bank, Heritage Bank, and the Nebraska Public Agency Investment Trust (NPAIT) were reviewed. A motion was made by Boruch to adopt a resolution approving Pinnacle Bank of Osceola and Shelby, Cornerstone Bank of Stromsburg and Polk, Heritage Bank and NPAIT as depositories for county funds. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. An application was also received from Union Bank and Trust's NFIT program but, at this time, the Treasurer does not have any funds on deposit with NFIT. Should the Treasurer wish to place funds on deposit with NFIT, accepting their application to be a depository will be revisited by the Board.

The 2025 wages for county employees were discussed. A motion was made by Boruch to adopt the following pay scale: experienced road employees, a maximum of \$25.43 per hour; county mechanic, a maximum of \$27.83 per hour; road foreman, a maximum of \$31.98 per hour; Weed Supt., a maximum of \$26.09 per hour; Highway Supt., a maximum annual salary of \$61,936.00; Bridge Inspector, a maximum annual salary of \$15,484; office clerk in the office of Highway Supt., Survey, Weed Supt., and Zoning Administrator, a maximum of \$24.76 per hour; Deputy Clerk, Deputy Treasurer and Deputy Assessor, \$24.76 per hour; office clerks in the office of Clerk, Treasurer, and Assessor, a maximum of \$23.16 per hour; Deputy County Attorney, a maximum annual salary of \$53,481.00; Chief Deputy Sheriff, a maximum of \$37.23 per hour; Sergeant, a maximum of \$36.44 per hour; Investigator, a maximum of \$35.86 per hour; Deputy Sheriffs, a maximum of \$34.01 per hour; dispatcher, a maximum of \$25.62 per hour; Custodian, a maximum of \$23.73 per hour; and Health Director, a maximum of \$35.87 per hour. Any other non law enforcement hourly employees' wages may be increased by a maximum of 3% per hour. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye.

Marcus Augustin and Nataly Sanley updated the Board on the activities of the hospital. November was a slower month for the facility and both an operating and an overall loss were reported. The urology clinic is going very well and the next clinic is basically already full. A new suction machine has been purchased and a \$25,000 grant has been received from the Dinsdale Foundation, with the funds to be put towards the sterilizer. The used ambulance purchased for transporting patients should be delivered by the end of the month but will need to be outfitted prior to be able to be put in service. The Foundation for Annie Jeffrey's annual wine and beer fest is scheduled for February 9<sup>th</sup> at the Rose Colored Glass in Stromsburg.

Health Dept. Director Darla Winslow updated the Board on the activities of the Health Dept. Things are going well at the new location in Stromsburg and a local handyman has been hired to finish some of the small projects Al Willits was unable to complete. The health department has been working with Four Corners District Health Department to bring a dental program to the local schools and nursing homes, utilizing dental students. The department is also teaming with the Center for Survivors and the Child Advocacy Center to form a community response team.

Tristan Perry, with the York County Juvenile Diversion Program, updated the Board on the most recent grant application to the Crime Commission for the program shared with Polk County. There will be a second grant application opportunity in January.

Highway Supt. Theis updated the Board on the work being done in the Road Dept. The well project at the Swedehome shop has been delayed until spring. Work on a culvert near 137<sup>th</sup> and W Roads was completed last week and a project near 138<sup>th</sup> and S Roads is underway. More salt will be procured to be mixed with sand and/or gravel for treating the county's hard surfaced roads.

There being no further business, the Board adjourned at 11:40 a.m. to meet again on December 24 <sup>th</sup> , 2024 and January 7 <sup>th</sup> , 2025. An agenda of the meetings will be available at the office of the County Clerk.
