The Child Advocacy Center Service Agreement was reviewed. A motion was made by Westring authorizing the Sheriff and the County Attorney to sign the Service Agreement for fiscal year 2022-2023 as presented. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye; Boss, aye.

The NACO Blue Cross – Blue Shield health insurance plans will see a 17% increase in the premiums for the plan year which begins July 1st after three years of little to no increases and the deductibles for the various plans increased by \$100. A motion was made by Boss to renew the \$2600 deductible PPO health insurance plan with the NACO Blue Cross Blue Shield group and to reimburse to the employee that portion of the deductible between \$500 and \$2600 that they themselves meet. In essence, the plan will be a \$500 deductible plan for the employee themselves and a \$2600 deductible plan for the spouse/children or family coverage paid for by those employees who wish to insure their family members through the county's group plan. The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye. Participation in the NACO health insurance program also provides life insurance and long term disability insurance to county employees who enroll in the plan.

Hunter Shain, with Rasmussen Mechanical Service, presented three different options for either repairing or replacing the existing boilers in the courthouse. The first option would repair the burner and fan on one of the two existing boilers which would give the courthouse heating two functioning boilers with up to 25 years of life. Option two would replace the boilers with cast iron sectional boilers with an expected life of 25 to 30 years. The third option would replace the boilers with a variable refrigerant flow system. With costs ranging from \$4,538.00 to \$445,453.00, a motion was made by Boss to accept Option #1, the lowest cost option. The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye.

Cal Marak with the Polk County Ag Society met with the Board regarding the liquor license required for the beer garden at the Polk County Fair. The Fair Board is requesting a license for July 21, July 22, and July 23 for events to be held in the grandstand/arena area. A motion was made by Boruch to approve Polk County Ag Society's request for a liquor license for a beer garden during the Polk County Fair on July 21st, 22nd, and 23rd, 2022. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye.

Emily Triplett, from the Osceola Good Samaritan Center, along with Erin Dickey and Grace Gerrard, representing the Midwest Covenant Home, met with the Board to discuss the additional costs incurred by their facilities due to COVID. The additional costs generally stem from unfundated mandates imposed regarding testing and screening of staff, residents and visitors to the facilities. They asked for the County to consider allocating a portion of their ARPA funds to these long term care facilities to offset these costs.

Highway Supt. Theis updated the Board on the work being done in the Road Dept. The fence has been relocated and dirt moved as requested on the clay hill project. Engineers from the dairy plan to use the backslope of the county road ditch to bury the line that would transport methane from the Butler County location to Double Dutch dairy and then into the Black Hills Energy pipeline.

There being no further business, the Board adjourned at 11:55 p.m. to meet again on May 24th and June 7th, 2022. An agenda of the meetings will be available at the office of the County Clerk.
