The Board approved the collateral pledged by Polk County banks and held in custody by the County Treasurer.

The following fees for the month of May were earned by the various offices and submitted to the County Treasurer. County Treasurer receipts show fees earned were credited to the appropriate county funds.

The proposed lease agreement for office space for the Veterans Service Officer was reviewed. The Lodge No. 65, A. F. and A. M. of Osceola, Nebraska is willing to lease the north 33 feet of the building located at 451 Hawkeye Street in Osceola to Polk County to be used by the Veterans Service Officer and the Veterans Service Committee. A motion was made by Boss to approve the lease agreement as presented. The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye.

Treasurer Swanson reported that there is one Tax Sale Certificate, purchased by the County on June 15, 2021, which is now required to be foreclosed. A motion was made by Boss to adopt a resolution directing the County Attorney to foreclose Tax Sale Certificate No. 900. The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye.

Jill Engel, who appeared for Randy Jones who had a last minute conflict, presented the annual report for Aging Partners. Locally they provide services to older adults through the senior centers and the office located in the courthouse with the goal of allowing residents to stay in their own homes. Their request for funding for the 2024-2025 fiscal year is \$18,386, a increase of $2\frac{1}{2}\%$.

In the absence of Highway Supt. Theis, Foreman Ericson updated the Board on the work being done in the Road Dept. There are several culverts that need to be cleared of dirt and debris, but it remains too wet. The semi is in York for repairs and the transmission has been replaced on one of the Caterpillar motor graders. Gravel bids will be opened at next week's meeting of the Board.

There being no further business, the Board adjourned at 11:50 a.m. to meet again on June 25th and July 2nd, 2024. An agenda of the meetings will be available at the office of the County Clerk.
