The County Jail Report for the month of May was not presented for approval.

The County's annual billing statement for property, liability and workers comp insurance from NIRMA was reviewed by the Board. The invoice indicated a nearly 38% increase over last year's premium but the premium could be lowered by choosing higher deductibles. After comparing the premiums, a motion was made by Boruch to not change the deductibles on any of the insurance coverages obtained through NIRMA. The motion was seconded by Westring and the roll call vote was Boruch, aye; Westring, aye; Boss, aye.

Weed Supt. Carlson reported to the Board on the Platte Valley Weed Management Area meeting he attended last week. Information provided at the meeting showed that since 2008, Polk County has benefited from noxious weed control along the Platte River at a value of over \$140,000. It was the consensus of the Board to continue to support the Platte Valley Weed Management Area and budget for a contribution to the weed management area in the next fiscal year.

Representatives of the public libraries in Polk County met with the Board to present their annual report. They expressed their appreciation for the county funds received and provided information regarding the services offered at the libraries. The funds open the door to additional funding through the Nebraska Library Commission and summer reading programs are underway.

Representatives of Protex Central, Inc., the company who installed the courthouse fire alarm system, met with the Board to discuss the issues they have been having with the system. Protex has had conversations with the manufacturer to determine a solution for the wireless devices dropping the signal between the second and third floors, triggering the system to send out false alerts.

Highway Supt. Theis updated the Board on the work being done in the Road Dept. He has received surveys regarding the bridge project, requesting cost estimates and information on the existing structure. New safety vests have been ordered for the crew and additional ones for the County Board will be ordered as well for their use when checking on road issues. Supt. Theis has learned through the courts that briefs in the County vs. Urban case have been submitted to the judge but no decision has been issued by the court.
