The County Jail Report for the month of May was reviewed by the Board and approved.

A motion was made by Westring to approve the reappointments of Ron Boruch, Robin Carlson, Rita Houdersheldt and Dr. Michael Ulffers to the Polk County Health Board. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye.

The agreement with the Lincoln/Lancaster County Child Advocacy Center, Inc. (also now known as BraveBe Child Advocacy Center) was reviewed. A motion was made by Boruch authorizing the Sheriff and the County Attorney to sign the Service Agreement for fiscal year 2023-2024 as presented. The motion was seconded by Westring and the roll call vote was Boruch, aye; Westring, aye.

The Board approved the list of unpaid taxes as presented by Treasurer Swanson. As of June 6, 2023, \$9,237.95 was left to be paid from the tax years 2019 thru 2021.

Representatives of the public libraries in Polk County met with the Board to present their annual report. They expressed their appreciation for the county funds received and provided information regarding the services offered at the libraries. Paying the fees for Overdrive, computers, better internet access, and children's programming were among the uses of the funds.

At 10:35 a.m., a motion was made by Boruch to go into executive session to discuss personnel matters. The motion was seconded by Westring and the roll call vote was Boruch, aye; Westring, aye. Also present were Sheriff Ladwig and the County Clerk. At 10:40 a.m., a motion was made by Westring to come out of executive session. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye. Chairman Westring stated for the record that no formal action was taken and that only personnel matters were discussed.

At 10:45 a.m., a motion was made by Boruch to go into executive session to discuss an application for burial assistance. The motion was seconded by Westring and the roll call vote was Boruch, ave: Westring, ave. Also present were the deceased next of kin and the County Clerk. At 10:50 a.m., a motion was made by Boruch to come out of executive session. The motion was seconded by Westring and the roll call vote was Boruch, aye; Westring, aye. Chairman Westring stated for the record that no formal action was taken and that only burial assistance matters were discussed. A motion was made by Boruch to approve the application for burial assistance as presented. The motion was seconded by Westring and the roll call vote was Boruch, aye; Westring, aye.

Highway Supt. Theis provided quotes for a profiler for the maintainers. A motion was made by Westring to purchase a profiler from Nebraska Machinery Company. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye.

A change order for additional crushed rock and the application for payment for the box culvert project were reviewed by the Board. A motion was made by Boruch approve both Change Order No. 1 and the Application for Payment as presented by Highway Supt. Theis for the Osceola Northwest box culvert project. The motion was seconded by Westring and the roll call vote was Boruch, aye; Westring, aye.

Highway Supt. Theis also updated the Board on the work being done in the Road Dept. Millings were hauled and spread at the fairgrounds last week. Safety videos are available through NIRMA and those covering topics of interest to the crew will be selected for viewing.

There being no further business, the Board adjourned at 11:55 a.m. to meet again on June 20th and 27th, 2023. An agenda of the meetings will be available at the office of the County Clerk.
