The County Jail report for the month of May was reviewed by the Board and approved.

The Board approved the list of unpaid taxes as presented by Treasurer Swanson. As of June 7, 2022, \$6,585.00 was left to be paid from the tax years 2016 thru 2020.

A motion was made by Westring authorizing Emergency Manager Logan Watts to apply for a credit card with a limit of \$3,000 with the cash advance limit set at zero. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye; Boss, aye.

The Board reviewed the Cash-In-Lieu option that is part of the County's cafeteria plan. A motion was made by Westring to continue to offer the cash-in-lieu program with the monthly cash option increasing to \$500 for the 2022-2023 plan year. The motion was seconded by Boss and the roll call vote was Westring, aye; Boss, aye; Boruch, aye. The increased amount will covering the rising costs of Medicare Supplement plans.

Clerk of the Courts Jodie Roberts met with the Board to discuss upgrades to her office. The painting project is nearing completion and a new desk is needed to accommodate the extra staff in her office, especially on court days. The county court files, which are currently still housed in a portion of the old County Court office space on the second floor, will soon be moved to the third floor. A motion was made by Westring to approve the purchase of the new office furniture for the courts. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye; Boss, aye.

At 10:10 a.m., a motion was made by Boruch to go into executive session to discuss personnel matters. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. Also present were Sheriff Ladwig and the County Clerk. At 10:25 a.m., a motion was made by Boruch to come out of executive session. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. Chairman Westring stated for the record that no formal action was taken and that only personnel matters were discussed.

Highway Supt. Theis reported that the plans for the box culvert project northwest of Osceola have been submitted by JEO to the State. Once the plans have been received from the State, the project can go out for bids. A motion was made by Boss authorizing either the County Clerk or the Highway Supt. to request bids for the Osceola Northwest Box Culvert project upon receipt of the final plans from the Nebraska Dept. of Transportation. The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye.

Highway Supt. Theis also updated the Board on the work being done in the Road Dept. All of the new 911 signs for the highways have been received and now need to be installed. Due to recent rains, gravel is needed on some of the county roads.

There being no further business, the Board adjourned at 11:55 a.m. to meet again on June 21st and 28th, 2022. An agenda of the meetings will be available at the office of the County Clerk.
