The County Jail Report for the month of June was not presented for approval.

A motion was made by Boruch to officially designate MIPS as the vendor to print and mail the postcards required by §77-1633 (3g). The motion was seconded by Westring and the roll call vote was Boruch, aye; Westring, aye; Boss, aye. The cost of the cards and postage will be shared by the entities who are required to participate in the special joint hearing.

The contract with Midwest Covenant Home for administering the Senior Services Program was reviewed. A motion was made by Boss to approve the contract for the 2025-2026 fiscal year which begins on July 1<sup>st</sup>. The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye.

Chief Probation Officer Carrie Rodriguez and Chief Deputy Probation Officer Morgan Campbell presented the annual report of District 5 Probation to the Board. Information regarding clients served in Polk County and a request for funding for the 2025-2026 fiscal year were given to the Board.

The Board approved the list of unpaid taxes as presented by Treasurer Swanson. As of July 1, 2025, \$5,520.68 was left to be paid from the tax years 2019 thru 2023.

At 10:20 a.m., a motion was made by Boruch to go into executive session to discuss an application for burial assistance. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. Also present were the next of kin of the deceased and the County Clerk. At 10:25 a.m., a motion was made by Boruch to come out of executive session. The motion was seconded by Boss and all members voted in the affirmative. Chairman Westring stated for the record that no formal action was taken and only burial assistance matters were discussed. A motion was made by Boruch to approve the request for burial assistance. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye.

Jill Engel presented the annual report for Aging Partners along with Mark DeMers, who oversees the local program for Midwest Covenant Home. Locally Aging Partners provides services to older adults through the senior centers and the office located in the courthouse with the goal of allowing residents to stay in their own homes. Their request for funding for the 2025-2026 fiscal year is \$18,846, a increase of  $2\frac{1}{2}\%$ .

Highway Supt. Theis also updated the Board on the work being done in the Road Dept. New safety vests have been distributed to the crew and were also provided to the commissioners. The new pickup ordered earlier this year has been built but has not been delivered to Husker Auto Group. There will be a meeting at the V Road bridge site with representatives from NDOT to review the project on Wednesday. The Caterpillar VisionLink program and the John Deere Link program were discussed for monitoring equipment performance. The flooding in the valley from last week's heavy rains is now under control and creeks back to normal but culverts that need to be repaired were identified.

There being no further business, the Board adjourned at 11:45 a.m. to meet again on July 15<sup>th</sup> and 22<sup>nd</sup>, 2025. An agenda of the meetings will be available at the office of the County Clerk.
