The following fees for the month of July were earned by the various offices and submitted to the County Treasurer. County Treasurer receipts show fees earned were credited to the appropriate county funds.

The County Jail Report for the month of July was reviewed by the Board and approved.

The Board approved the collateral pledged by Polk County banks and held in custody by the County Treasurer.

A motion was made by Westring to allocate the following levies for those political subdivisions subject to the County's levy authority:

The county budget was reviewed by the Board. A motion was made by Westring to increase the total 2023-2024 funds subject to limitation by an additional 1%, from  $2\frac{1}{2}$ % to  $3\frac{1}{2}$ %. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye; Boss, aye.

The Board received a letter from the Nebraska Director of Veterans' Affairs certifying that Kenneth Toline was eligible for the position of Polk County Veterans' Service Officer.

Clerk Girard reported that the checking account in the name of the Polk County Service Committee which was used to pay operating expenses at Pinnacle Bank was closed last week and the funds remitted to the County Treasurer. Operating expenses for the Veterans' Service Office will be paid through the county's claim process. The closing of the account was verbally approved by the Board. The Soldiers Relief Fund checking account will remain open as an Attorney General's opinion rendered in 1998 allows the Veterans Service Committee to have such an account to provide assistance to qualifying veterans.

The renewal lease with the City of Lincoln on behalf of Aging Partners was reviewed. The lease will be for office space in the courthouse to be used by Aging Partners Personal & Family Services and the terms are the same as the previous year's lease, with the exception of being for the usual 12 months instead of 16 months. A motion was made by Boruch authorizing the Chairman to sign the lease as presented. The motion was seconded by Westring and the roll call vote was Boruch, aye; Westring, aye; Boss, aye.

At 10:30 a.m., a motion was made by Boruch to go into executive session to prevent needless harm to an individual. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. Also present were the County Sheriff and the County Clerk. At 10:35 a.m., a motion was made by Boss to come out of executive session. The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye. Chairman Westring stated for the record that no formal action was taken while in closed session.

Sheriff Ladwig discussed purchasing a new Chevrolet Tahoe for use as a patrol vehicle at the state bid price. A motion was made by Boss authorizing the Sheriff to purchase a 2024 Chevrolet Tahoe. The motion was seconded by Westring and the roll call vote was Boss, aye; Westring, aye; Boruch, aye.

Highway Supt. Theis updated the Board on the work being done in the Road Dept. The railroad crossing project is now complete but the poorly signed detours created problems around Stromsburg. The NIRMA training provided to the crew covered preventative maintenance for equipment and tips for maintaining gravel roads. The cost of a motorized hand held post driver would be eligible for NIRMA's ASSIST grant program. The scrap tire collection grant was submitted to the state last week.

There being no further business, the Board adjourned at 11:55 a.m. to meet again on August  $22^{nd}$  and September  $5^{th}$ , 2023. An agenda of the meetings will be available at the office of the County Clerk.
