After reviewing the specs for the box culvert project, an addendum will be made to update the preferred date of completion for the project. The engine in need of repairs, as reported last week, has been removed from the maintainer and is ready to be repaired. Fiber optic lines for improved internet service are being installed in the rural area around Shelby. New tires are being installed on a couple of the motorgraders.
