The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye.

The County's real estate inventory was reviewed by the Board and signed by the Chairman.

A motion was made by Boruch to appoint John Pokorney as a member of the Polk County Veterans Service Committee. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye.

A motion was made by Boruch to adopt a resolution renewing Polk County's membership in the Nebraska Regional Interoperability Network (NRIN). The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. NRIN allows information to be shared among emergency and communications centers to help mitigate an emergency that threatens any location. Continuing Polk County's membership in NRIN was recommended by Emergency Manager Watts.

A motion was made by Westring authorizing the Chairman to sign the agreement for Emergency Protective Services with Region 5 Systems for the 2025-2026 fiscal year. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye; Boss, aye.

Assessor Krance met with the Board to review the proposals from Eagleview to renew the contract for pictometry. In light of a recent Attorney General's opinion potentially restricting an assessor's on the ground access to properties for assessment purposes, a motion was made by Boss to enter into an agreement with Eagleview to provide 3" aerial imagery. The imagery would be provided twice during a six year period. The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye. Assessor Krance will contact Eagleview for the drafting of the contract.

Toby Johansen met with the Board to discuss the maintenance of the Wesley Chapel Cemetery, the largest of the three abandoned cemeteries in the county that Polk County maintains under the abandoned cemetery statutes. A motion was made by Boruch to increase the fee paid for the annual maintenance of Wesley Chapel to \$800.00. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye.

Veterans Service Officer Kenneth Toline and members of the Veterans Service Committee updated the Board on the activities of the Veterans Service Office. The number of veterans and members of their families seen by the VSO remains high and continuing education for the claim process has been completed. To provide more privacy during appointments and screenings, the committee is recommending that some remodeling be done to the building leased from the Osceola Masonic Lodge. When VSO Toline was initially hired to fill the position, there were no benefits attached to the position. He is now asking for vacation and sick leave benefits, comparable to any other Polk County employee who works the same number of hours per week. A motion was made by Boss to approve prorated vacation and sick leave for the Veterans Service Officer. The motion was seconded by Boruch and the roll call vote was Boss, aye; Boruch, aye; Westring, aye.

At 10:45 a.m., a motion was made by Boruch to go into executive session to discuss an application for general assistance. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. Also present were the applicant and the County Clerk. At 10:50 a.m., a motion was made by Westring to come out of executive session. The motion was seconded by Boss and all members voted in the affirmative. Chairman Westring stated for the record that no formal action was taken and that only assistance matters were discussed. A motion was made by Westring to approve the applicant's request for assistance. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boruch, aye; Boss, aye. The county will pay the amount of the back rent owed after deducting the amount of assistance received from Blue Valley Community Action.

Highway Supt. Theis updated the Board on the work being done in the Road Dept. He had an opportunity to personally thank Congressman Flood for the congressman's assistance in requesting federal funding for the Lone Star West project. A pre-construction meeting will

possibly be held on September 4<sup>th</sup> for the Shelby North and Osceola North overlay projects. With the recent drier weather, the crew has been able to resume work on those culverts needing to be replaced or repaired. The dump truck and pup are back in service and operating properly but issues are being experienced with the semi tractor. Each member of the crew has been given the opportunity to request additional gravel for their route for fall delivery.
