




PROPOSED CONSTITUTIONAL AMENDMENTS

Proposed Amendment No. 1

Proposed Amendment No. 2

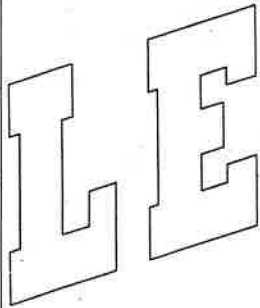
